## **1. Purpose / situation**

This paper introduces the revised Outbreak Incident Management Policy and Procedure for approval, which is required within the organisation to support managers and staff in the management of Infection Prevention and Control (IP&C) outbreaks which arise within Public Health Wales settings. The established Infection Prevention Control Group, have been consulted on the documents and the documents have been through the wider consultation processes in Public Health Wales.

## **2. Background**

The current interim Policy was approved by the Quality and Safety Committee in April 2021 and since wider consultation has taken place as per the organisational process for the approval of policies.

## **3. Description/Assessment**

Following a review of the current documents led by the Lead IP&C Nurse, comments having been requested and received from IP&C Group members, Consultant in Communicable Disease Control representatives, HealthCare Associated Infection & Antimicrobial Resistance Programme (HARP) leads and Microbiology, the following minor amendments have been made aligned to national guidance.

- The updated national policies and documents have been reviewed and referenced within the Policy;
- The Outbreak Control Team (OCT) meeting is to be chaired by the Executive Director of Quality, Nursing and Allied Health Professionals or nominated deputy;
- A new flow chart has been included setting out the process for the reporting and management of outbreaks;
- Standard operating procedure for outbreak investigation, management and control has been inserted.

### **3.1 Well-being of Future Generations (Wales) Act 2015**

*Effective outbreak management is an important aspect of the organisation's governance arrangements, and, as such, helps the organisation to improve the quality and safeguard the high standards of the services provided by Public Health Wales.*
