Screening Division

- Pathology timeliness for cancer screening programmes
- Clinical workforce in North Wales for Breast Screening Programme; recruitment to new breast clinician post, working with Health Board around shared job plans for new potential recruitments.
- Progressing recovery, not confirmed if budget will include any recovery funding yet. Conversations ongoing with Welsh Government (WG)

Overview of Key Activities During the Month

- "A Strategic Approach to Infrastructure Development in Public Health Wales" covering estates, digital and capital funding developed and shared with Executive team
- The development and approval of the discretionary capital expenditure plan for 2023/24, and an update on strategic capital replacement programme. The management of the approved plan now delegated to the capital monitoring group.
- Held third cross organisational workshop to map the planning system in Public Health Wales, using QOS methodology, and identified key improvement areas
- Facilitated a workshop for the WHOCC Directorate on our long term strategy
- Planning and preparation for a review by the DHCW Cyber Resilience Unit at the beginning of July, who will audit us against the Cyber Assessment Framework
- Development of an outline plan of the Digital Services division's activities for 2023-24 and deliver against the IMTP milestones

Successes

- Launch of the brand strategy to staff following engagement with Directorate Senior Leadership Teams. This sets out our brand position and resources available to support staff in telling our story.
- Significant coverage of the evidence base to support healthy food environments including ITV, Channel 4, The Guardian, Echo, and Bauer. The "Time to Talk" survey findings were used as a news hook to show the strong public support, timed ahead of Welsh

Government's announcements, around banning multi-buys on unhealthy food. Both Julie Bishop and Ilona Johnson were interviewed. We also produced and circulated a stakeholder brief to harness support from food and obesity sector allies.

- Communications Team has led on communications and engagement to support DESW with communicating the change around low risk screening recall pathway announced 26 June
- Following a four day external audit process, Public Health Wales achieved ISO 14001- Environment Management accreditation in June 2023 for our office environments that include Capital Quarter 2, Cardiff, Matrix House, Swansea and Clwydian House, Wrexham.
- The Programme Manager for Decarbonisation was successfully appointed to work across the organisation to take forward and embed Public Health Wales' Decarbonisation Action Plan
- Facilitated four all staff engagement sessions shaped around the implementation of our new long-term strategy, which will be presented to BET in August.
- Implemented changes to the DESW digital systems and data to deliver the low-risk recall pathway
- Successfully recruited into two vacant roles to the Digital Services development team, whilst also progressing the recruitment of new key cyber and delivery roles
- Conducted a full review of the Digital Services risks with directorate leads, with an emphasis on cyber and business continuity
- Defined actions from the series of Discovery phases and Architecture review, with Digital Services development and data teams incorporating recommendations into their plans
- Delivery of a Discovery phase for the next steps of our breast screening systems cohort selection tool.

Any Concerns being managed:

- Plans underway to remediate Welsh Language compliance issues on our web site and contributing to the action plan in response to the Welsh Language Commissioners' investigation
- The implementation of our new cloud-based web proxy (ZScaler) may disrupt some digital services in July due to the complex configuration required. The Digital Services division are working through systems that may be affected to mitigate risk of outages during switchover.

The Solutions Platform is a live portal to evidence, data, practical tools and resources to inform and support policy making, investment prioritisation, and cross-sector action, and monitor progress, towards achieving healthy prosperous lives for current and future generations in Wales and beyond. The Solutions Platform is the result of wide stakeholder engagement, expert input and applying an innovative approach and framework over the past four years, delivering to a Memorandum of Understanding between the Welsh Government and the WHO.

The report was cited in the Welsh Government press release and extensively in national and regional online articles including in the [Independent](#), as well as colleagues from Health Improvement Division delivering TV and radio interviews.

Building the social relationships of older people in Wales: challenges and opportunities:

Social capital is a protective factor for health and well-being, and differences contribute significantly to health inequalities in Wales. This paper provides a rapid review of older people's social relationships and networks and how this has been impacted by the COVID-19 pandemic and the more recent cost of living crisis. The report identifies policy and practice examples that can promote, sustain and strengthen older people's social relationships and networks as a means of overcoming challenges and building the social capital of current and future older generations.

International Horizon Scanning Report - May 2023 - universal primary free school meals.

The report focussed on the impact of universal primary free school meals programmes, with specific consideration of approaches taken by other countries to address: 1) the wider determinants (e.g. inequities, educational attainment, and Financial health / COLC / child poverty and food insecurities) and 2) social impacts (e.g. social return on investment, including social skills, stigma, culture, play time/lunch time experience and local sourcing with associated economic and social benefits to local/foundational economy – sustainable procurement and menus)

Has Brexit changed detection and prevention of illicit trade in drugs, alcohol, and tobacco in Wales?

In the context of record numbers of deaths related to drug and alcohol, and smoking still the most prevalent cause of avoidable death in Wales, this briefing explores how Brexit has impacted international collaboration by Wales and the UK on detection and prevention, as well as the supply and demand of illicit goods in Wales. It calls on decision-makers to consider the impacts of Brexit when developing their

response to illicit trade in these goods and in particular, around planning for Wales's new freeports.

- Sickiness absence rates continue to impact on the ability of the Directorate to provide sufficient support on Risk Management and Datix Web gaps in central risk management support are being absorbed.

Overview of Key Activities During the Month

- Data Science Community Event – organised and ran a very well-received cross-organisation workshop, building skills and sharing knowledge to an audience of over 70 people.
- Prevalence of Disease – Cardiovascular Disease analysis and projections completed.
- Primary Care Cluster - profiles development started, with ~60 attendees across a range of organisations and roles.
- Three agile scoping reviews published on the Public Health Wales (PHW) website [Evidence - Public Health Wales \(nhs.wales\)](https://www.nhs.uk/evidence-public-health-wales/)
- Supported Health Improvement team to complete a grant application to the UKRI.
- Continuing to support internal and external colleagues in the development of evaluation e.g., presented at Cardiff and Vale University Health Board (CVUHB) Local Public Health Team learning and development session on evaluation in Public Health.
- Leading and supporting the development of evaluation proposals across multiple programmes including;
 - local innovation (eg Prehab to Rehab, Inverse care law in BCUHB),
 - national vaccine programmes,
 - national wellbeing conversation (Hapus Strategic Partnership Theory of Change).
- Research and Evaluation Strategy approved by Knowledge, Research and Information Committee (KRIC), Board and BET now progressing to implementation stage.
- Presented Networked Data Lab Wales (NDL) analysis to Welsh Government and NHS Wales Modelling collaborative, on Unpaid Carers, utilising linked local authority and primary care data.
- Met with NHS England National Diabetes Audit for 2023-24 publication of England/Wales data.

Successes

- Chairs of PHW, Digital Health and Care Wales (DHCW), Health Education and Improvement Wales (HEIW) reached agreement on the implementation of the Artificial Intelligence (AI) commission, with Iain Bell as the PHW Executive Lead.
- Selected a partner for the National Health Application and Infrastructure Services (NHAIS) Cohort Selection and Diabetic Eye Screening Wales (DESW) GP Referrals Project.
- Invited to develop symposium at 2nd WHO Symposium on the Future of Health Systems in the Digital Era.
- Collaborative research proposal on Real-time Multiplex Public Health Surveillance Systems, led by Imperial College, partnered with the Alan Turing Institute now progressed to the second stage with UK Research and Innovation (UKRI); also supporting two Health Determinants Research Collaboratives submissions have also reached the second stage for National Institute for Health and Care Research (NIHR) funding, with multiple partners across Wales.
- Advanced Data Engineer, Lead Delivery Manager and Lead Cyber Security Manager positions approved by job evaluation panel and can recruitment to the roles has commenced.
- The new [Cancer Reporting Tool](#) (official statistics) was released on 22 June 2023, with incidence figures up to 2020 for breast, colorectal, lung, ovary and prostate cancer. There has been excellent feedback from users. The remaining sites will be added in September 2023, along with a new publication of more timely pathology cancer stats.
- Positive feedback - JLH and CG in Research and Evaluation (R&E) division supported the evaluation of the pilot implementation of 'IPC workbooks for preventing infection in care homes and domiciliary care in Wales: Guidance for social care staff'. The work has been widely well received and has been also accepted for IP2023 Conference as a poster and entered for a Nursing Award. *"Thanks Charlotte, truly grateful for the support received by you both to get this document out and the impact on the sector."*

Any Concerns being managed:

- The delay in getting job descriptions banded continues which is resulting in delays in filling key posts. People & Organisation Development are aware of the ongoing issues being experienced.
- Our laptops are insufficiently powerful to run more complex data science and modelling processes. We are working with the digital services team to find an interim solution as we consider our strategic cloud solutions.

Forward Look of key activities for next month

- Prevalence of Disease – Cancer (top sights) and smoking projections are due to be completed this month (July 2023). Respiratory disease has been started (due August), after which we will move on to mental health (due September)

- Initial findings from the Annual Knowledge and Research User Survey.
