Outbreak Management Policy

Policy Statement

Outbreaks and incidents of infection have serious consequences for service users and NHS organisations including; mortality, morbidity, distress, delays in treatment and impacts on service provision.

This policy is primarily intended to cover outbreaks involving staff and service users utilising Public Health Wales as an NHS healthcare setting.

The purpose of this policy is to:

- ensure a rapid, well-co-ordinated response to an outbreak,
- verify that there is an outbreak of infection
- To investigate the extent and to identify the source.
- Make efficient use of all health service resources in order to contain the outbreak
- Limit the spread of infection and minimise the disruption of clinical services stopping the outbreak and preventing where possible a recurrences.

Policy Commitment

This policy states the commitment of Public Health Wales to ensuring the safety of staff within the workplace.

The policy also guides staff to be able to recognise an outbreak and how to handle the situation.
